## CITRIC ACID CYCLE 0-11-25

**DESCRIPTION:** *Citric Acid Cycle* is an energy producing high potassium and phosphite foliar nutrient specifically designed for use on intensively managed turf such as golf courses, athletic fields, etc.

**APPLICATION:** Apply with any equipment that delivers a fine even spray mist to the target area utilizing 02-04 tips for a total spray volume of 20-40 gpa (200-350 L/ha). Do not water in. Wait at least 2 hours to irrigate.

### RATE OF APPLICATION:

**Warm Season Turf:** Apply 3-9 fl oz / 1000 sq ft (10-30 L/ha) biweekly or as indicated by turf conditions. Use higher rates where a deficiency is known.

**Cool Season Turf:** Apply 3-6 fl oz / 1000 sq ft (10-20 L/ha) biweekly or as indicated by turf conditions. Use higher rates where a deficiency is known.

**COMPATIBILITY:** *Citric Acid Cycle* is tank mix compatible with many systemic fungicides, insecticides, and nutrient solutions. Jar test when in doubt. For best mixing results, remove tank strainer prior to product addition.
